Following the Share Purchases, the total number of Ordinary Shares held as treasury shares by the Company is 443,000 Ordinary Shares. The total number of Ordinary Shares in issue is 17,746,929 (including shares held as treasury shares). Therefore, the total number of voting rights in the Company is now 17,303,929 which may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in the Company under the FCA’s Disclosure Guidance and Transparency Rules.
